

Relationships and Health Education Parent Consultation

From September 2020 it is a statutory requirement that all schools in England and Wales are teaching Relationships and Health Education as a fundamental part of the curriculum. The RSE statutory guidance (2019) along with the SCARF support materials and staff training were used to inform our decisions about how we teach Relationships and Health Education.

At Britannia we believe that working in partnership with parents and carers is a crucial step in effectively meeting individual pupil needs and continuing to develop a curriculum offer that can help each pupil reach their potential.

Key findings

- Parents understand what will be covered in PSHE at Britannia.
- Parents would like to be informed about upcoming units of work and given information about what will be taught so they are more prepared to support their children with their learning.
- The information given to parents about Relationships and Health education is clear and parents feel they are able to speak to relevant members of staff should they have concerns or queries.
- Parents are pleased about the PSHE content and how we will prepare children for life in the modern world.
- Most parents know about the right to withdraw their children from Sex Education lessons.
- 58% parents believe children should be taught the correct names for our body parts in Key Stage 1.
- 51% of parents believe children should be taught about puberty in Year 5 and 6. 100% of parents answered that children should be taught about Puberty by the time they leave primary school.
- 14% believe Sex Education should happen at high school and is not appropriate for primary age.

- Parents were mainly happy with the content of the curriculum and the age appropriateness of some lesson content. Those who expressed concerns were most concerned about Sex Education being taught too early.
